

CONDITIONS governing the 2018 Gazprom Neft Cup KHL International Open Kids' Hockey Tournament

1. Tournament management

- 1.1. Responsibility for managing of the Tournament rests with the Organising Committee.
- 1.2. Work directly related to preparations for and running the tournament rests with the Executive Directorate, which is responsible for day-to-day liaison with hockey academy representatives, players, trainers, referees and other persons involved in organising the tournament, including by telephone, by post, and by electronic mail (e-mail).
- 1.3. The decisions of the Organising Committee and the Executive Directorate are binding on all Tournament participants.

2. Tournament rules

- 2.1. The Tournament will be held pursuant to the IIHF Rule Book 2014–2018 of the International Ice Hockey Federation (IIHF), excluding those instances cited in 9.1 of these Conditions.
- 2.2. Tournament participants must demonstrate a knowledge of and abide by the IIHF Rule Book and by the terms of these Conditions.

3. Tournament venue and dates

- 3.1. The tournament will take place in the cities of Sochi and Omsk, between 19 and 26 April 2018.

4. Tournament plan

- 4.1. Teams are divided into two groups – “East” and “West”, based on location.
- 4.2. East and West Group matches are divided into preliminary (elimination or knock-out matches) and final matches.
- 4.3. Those teams taking first place in the West and East Groups will compete in the Super Final of the Gazprom Neft Cup.

5. Tournament Participants

- 5.1. Participation in the Tournament is open to teams from hockey academies receiving an official invitation from the Tournament Organising Committee and comprising players born in 2007, as well as players born in 2008 and holding a medical certificate giving them the right to play on such team at an older age.
- 5.2. Management of hockey academies must confirm their participation in the Tournament by 30 January 2018 by forwarding an official letter and a Preliminary (Detailed) Application (Appendix 1 of these Conditions) to the address of the Executive Directorate. Such Preliminary Application may include no more than 40 (forty) players. The application shall include the following information on each player: last name, first name and patronymic (full name), date of birth, position, and squad number. A photo must be submitted for every player included in the Preliminary Application. Preliminary Applications will be posted on the official Tournament Internet site, at <http://www.gazprom-neft.ru/hockey/cup>.
- 5.3. Management of hockey academies must forward the following information to the Executive Directorate by 20 March 2018: team arrival and departure dates, and the total number of accompanying persons (e.g., parents) for whom additional hotel accommodation, subsistence and transportation will be required throughout the Tournament.

6. Adjudication of Tournament results

- 6.1. Preliminary matches in the East and West Groups will be played on a round-robin (all-play-all) basis, in a single round.
 - 6.1.1. A draw will be held to divide the teams of each group into four further sub-groups – A, B, C and D. In holding the draw hockey academies' standing in previous Tournaments will be taken into account, as well as 2007-generation teams' results in regional, national and international competitions, and the geographical location of individual hockey schools. No sub-group shall include more than two teams representing a single Inter-regional Coordination Centre of the Russian Ice Hockey Federation.
 - 6.1.1.1. The Avangard team (Omsk Oblast) will not be included in the draw, and will be given a place in sub-group A (place A1) in the East Group, in advance. The Salavat Yulaev team (Ufa) will not be included in the draw, and will be given a place in sub-group A (place A2) in the East Group. A match between Avangard (Omsk Oblast) and Salavat Yulaev (Ufa) will be included in the East Group Opening Ceremony.

6.1.1.2. The CSKA team (Moscow) will not be included in the draw, and will be given a place in sub-group A (place A1) in the West Group, in advance. The Lokomotiv team (Yaroslavl) will not be included in the draw, and will be given a place in sub-group A (place A2) in the West Group, in advance. A match between CSKA (Moscow) and Lokomotiv (Yaroslavl) will be included in the West Group Opening Ceremony.

6.1.2. Team rankings will be determined on the basis of the greatest number of points gained in matches. In the event of a tie at the end of regulation play teams will take turns in a (3-shot) three-shot shoot-out; in the event of a tie at the end of such shoot-out, shots will be taken, in turn, until one team gains the lead.

6.1.3. Three (3) points will be awarded for a win in regulation time, two (2) points for a shootout win, one (1) point for a shootout loss, and zero (0) points for a regulation loss.

6.1.3.1. In the event of two or more team rankings being equal, advantage will be given to the team demonstrating the best performance on the following terms (shown in order of priority):

a) a regulation win;

b) a shootout win;

c) the difference between goals scored and goals conceded in regulation playing time;

d) the number of goals scored; and

e) the lowest penalty time (the lowest number of penalty minutes) accumulated.

6.1.3.1.1. Where the above criteria are identical the same criteria will be applied across all matches in that sub-group.

6.1.3.1.2. In the event that the above criteria remain identical places will be determined by a draw.

6.1.3.1.3. The following will take part in such draw: official representatives of the Executive Directorate, the Referee Board, and those teams tying on points. The Executive Directorate will, in advance, prepare sealed envelopes containing pieces of paper showing team rankings (I, II, etc.). The first to draw an envelope will be the representative of whichever team is first by alphabetical order, who will open the envelope showing the place to be taken by his team thereafter. Representatives from other teams will then determine their teams' places on the same basis. Such draw shall take place no later than two hours before the start of the final matches.

6.2. Participants in the West Group and East Group finals will be determined on the basis of all sub-group matches.

6.2.1. Those teams occupying I and II place in their sub-groups will compete in "play-off" matches to compete for I to VIII place.

6.2.2. Those teams occupying III place in their sub-groups will compete in play-off matches to compete for IX to XII place.

6.2.3. Those teams occupying IV place in their sub-group will not take part in final matches and will be awarded XIII place.

6.2.4. In final matches, in the event of a tie at the end of regulation play, teams will take turns in a (3-shot) three-shot shoot-out; in the event of a tie at the end of such shoot-out, shots will be taken, in turn, until one team gains the lead.

6.3. Those teams occupying I place in the East and West Groups will meet in the Super Final. In the event that the final game results in a tie at the end of standard playing time, the winner will be determined through a shootout, with teams each taking a series of three shots in turn. In the event that the score remains tied, the game will proceed to a "sudden death" shootout to determine the winner.

6.4. Adjudication of results for matches cancelled or for which results are annulled (disqualified):

6.4.1. where a match takes place and is completed, and the team under penalty loses, the result of the match is not annulled and remains the same.

6.4.2. where a match takes place but is not completed, or where a match takes place but the team under penalty wins, the result of the match is annulled and the team in question is deemed to have suffered a technical defeat – 0:5, although points are not awarded. The competing team is deemed to have secured a technical victory – 5:0 and is awarded three points.

6.4.3. In the event of a team arriving more than 15 minutes late to a match, and in the absence of any explanation for such delay, or any information as to their expected time of arrival, an Official Game Sheet will be collated and signed by the Chief Referee regarding their non-appearance, and the team deemed to have suffered a technical defeat – 0:5.

7. Application Procedure

7.1. The Official Application to participate in the Tournament (Appendix 2 of these Conditions) should be forwarded to the Admissions Committee (comprising representatives of the Executive Directorate and the Referee Boards of the West and East Groups).

7.2. The Official Application may include no more than 25 persons, including: two goalkeepers, 20 on-ice players, and three official representatives (team manager, coach, doctor) from the Preliminary (Detailed) Application.

7.3. The Official Application, endorsed by the forwarding organisation and appropriate medical agency, should be submitted in duplicate and include: the names, surnames and patronymics of all players; their dates of birth; their permanent or current registered addresses; their squad positions; and their usual squad numbers.

7.4. Each team is required to append the following to their Official Application:

7.4.1. the birth certificate for every player (original);

7.4.2. a statutory medical insurance certificate (copy);

7.4.3. a hockey identity card for each hockey player, showing:

a) a recent photograph;

b) the official seal or stamp of such player's place of education;

c) the official seal or stamp on behalf of any agencies responsible for registration at the player's permanent place of residence; and

d) confirmation of each player's acceptance at a hockey academy, endorsed with the official seal or stamp of such academy.

If such identity card does not meet the above requirements, or if a player does not have a hockey identity card, certification must be provided from a municipal or local housing or utilities organisation (bearing the seal or stamp of such organisation), or stamped certification from a school of general education. It is mandatory that these documents include: the name, surname and patronymic of each player, his date of birth, and his current or permanent registered address.

7.5. Assuming the above requirements are met, the participant and/or team will be admitted to the Tournament.

7.6. The Admissions Committee must commence no later than 15 minutes prior to the start of team training.

7.7. If a team, for any good reason, does not engage in team training the Admissions Committee may take place no later than one hour prior to the start of such team's first match in the Tournament.

8. Tournament Programme

19 April	Arrival of teams in sub-group D, acceptance of Official Applications, team training.
20 April	Arrival of teams in sub-groups A, B, and C, acceptance of Official Applications, team training, East and West Group preliminary rounds, meeting of Executive Directorate with participation of team officials and East and West Referee Boards.
21 April	Opening matches and official Tournament East and West Opening Ceremonies.
22 April	Elimination (knock-out) and final West Group and East Group matches.
23 April	Final East and West Group matches, official Awards Ceremonies and Closing Ceremonies.
24 April	Departure of teams not taking part in the Super Final. Winning West Group team arrives in Omsk.
25 April	Tournament Super Final, Awards Ceremony and Tournament Closing Ceremony.
26 April	Super Final teams depart.

9. Conditions governing Tournament matches

9.1. Each game consists of three periods, each comprising 15 minutes' total playing time.

9.2. Matches will be attended by doctors and medical personnel.

9.3. Cleaning and resurfacing of the ice will take place prior to the start of each match, followed by at least five minutes' warm-up for hockey players, on the ice.

9.4. Breaks between periods during preliminary rounds (excluding the opening matches) will be five minutes long, and there will be no resurfacing of the ice.

9.5. The following breaks will be set during final matches (excluding the Super Final):

9.5.1. between periods I and II – 5 minutes; ice resurfacing will not occur.

9.5.2. between periods II and III – 15 minutes; ice resurfacing will take place.

9.6. The following breaks will be set during the Opening Ceremony and the Super Final:

9.6.1. between periods I and II – 10 minutes; ice resurfacing will not occur.

9.6.2. between periods II and III – 15 minutes; ice resurfacing will take place.

9.7. Official scorers will present match scorecards to the Referee Board. Each scorecard will be assigned a serial number for the match:

- 9.7.1. West Group: Bolshoi Ice Dome – odd numbers; Iceberg Skating Palace – even numbers.
- 9.7.2. East Group: Arena Omsk – odd numbers; Avangard Hockey Centre Arena – even numbers.
- 9.8. No later than 30 minutes prior to the start of each match the coach will hand the official scorer, present in the Situation Room, the scorecard for the match.
- 9.9. At the end of each match the Chief Referee must obtain an Official Game Sheet from the official scorer; verify this; make any notes, as appropriate; sign it; and, no later than 30 minutes after the end of the match, give the Official Game Sheet to the coaches of the competing teams who, in turn, are obliged to verify and sign it. All signatures made on the Official Game Sheet by coaches or medical personnel should be made in the Situation Room.
- 9.10. The team shown first on the fixture list is the “home” team, and plays in a dark strip. The team shown second on the fixture list is the “away” team and plays in a light strip, in a contrasting colour.
- 9.11. Changes to hockey players’ team numbers during the Tournament are not allowed.

10. Presentation of awards to teams and participants of the Tournament

- 10.1. The Organising Committee will make the following awards on the basis of all games played throughout the Tournament.
- 10.1.1. The winning team in the Super Final will be awarded the Gazprom Neft Cup (albeit on a temporary basis only). A shield will be placed at the base of the Gazprom Neft Cup showing the name of the winning team and the year. The management of the winning team may determine, independently, where the Gazprom Neft Cup is to be kept, but no less than 60 calendar days prior to the next Tournament the Executive Directorate will retrieve the Gazprom Neft Cup from the winning team and present them with a smaller copy of the Cup as a replacement.
- 10.1.2. The losing team in the Super Final will be awarded a commemorative prize.
- 10.1.3. Those players and coaches taking I, II and III place in the final West and East Group games will be awarded gold, silver and bronze medals, respectively.
- 10.1.4. Those teams placed I, II and III will be awarded a “Tournament Participant” prize at the official East and West Group Awards Ceremonies.
- 10.1.5. Those teams taking IV to VIII place in the East and West Groups will, at the end of their final matches, be awarded a special “Tournament Participant” prize.
- 10.1.6. Special individual awards will be made to the best goalkeeper, best defender, best forward, most productive player (in terms of goal and passes) and best player, in each of the East and West Group preliminary rounds.
- 10.1.7. A special prize (a “fair play” award) will be awarded to the most disciplined team (i.e., the team achieving the lowest amount of penalty minutes) in the East and West Groups, with the prize for the Most Disciplined Team nomination going to the captain of that team.
- 10.1.8. Special prizes will be awarded to the best coaches in the East and West Groups.
- 10.1.9. Special prizes will be awarded to on-ice officials in the final matches of the East and West Groups.
- 10.1.10. At each match of the Tournament special prizes will be awarded to the best player from each team. At the end of the match the coach will determine the best player on his team and advise the linesmen on the rink of that player’s number. The official scorer will record this player on the match scorecard. Before the teams shake hands the commentator will announce the best players of the match, who will then approach the referees’ table, where they will receive their awards from members of the East and West Group Referee Boards.
- 10.2. Additional prizes may be given by the Organising Committee and organisations involved in the Tournament, as listed and approved by the Organising Committee.

11. Refereeing of Tournament matches

- 11.1. A separate Referee Board is established for each of the East and West Groups. The Referee Boards for the East and West Groups comprise: a Tournament Chief Referee and Chief Official Scorer, their deputies, and a Chief Medical Officer.
- 11.2. The Referee Board’s responsibilities include:
- 11.2.1. participation in the Tournament Admissions Committee;
- 11.2.2. the appointment of match referees, including the Referee Board for the East Group as referees at the Super Final;
- 11.2.3. the disqualification of hockey players and team officials;
- 11.2.4. participation in supervising preparations for and the conduct of matches at venue rinks;
- 11.2.5. compilation of match results.
- 11.2.6. consideration of appeals.
- 11.2.7. distribution and collection of Official Game Sheets.
- 11.2.8. compilation of statistics.
- 11.2.9. compilation and updating of data displayed on venue information stands.

- 11.2.10. distribution of pucks to Chief Referees; and
- 11.2.11. managing the participation of members of the Referee Board in recognising the best players and teams (of those in IV to XIII place);
- 11.3. The Referee Board is responsible for refereeing matches under the three-official system (one Chief Referee and two linesman) together with seven off-ice officials: the chief scorer, game timekeeper, statistician, two penalty timekeepers and two goal judges.
- 11.3.1. Prior to the start of a match the Referee Board is responsible for:
 - 11.3.1.1. assessing the hockey pitch (rink) and assessing the quality of the ice and its suitability for the match;
 - 11.3.1.2. checking the bulletin board; and
 - 11.3.1.3. confirming all players taking part in pre-match warm-ups have the full and correct kit and strips (uniforms). The Referee Board at any match has the right to refuse admission to any players incorrectly equipped or dressed.
- 11.3.2. At the end of a match the Referee Board is responsible for:
 - 11.3.2.1. making a note in the Official Game Sheet under "Disciplinary faults by players and team officials" in the event of a player and/or team representative being awarded a penalty for misconduct prior to the end of a game or in the event of a match penalty being awarded; and
 - 11.3.2.2. checking the Official Game Sheet (final score, penalty minutes, goal scorers, pass makers, etc.)

12. Tournament appeal procedures

- 12.1. The management of any team wishing to contest the results of a game must advise the Chief Referee and a representative of the opposing team of this immediately after such game. Any such appeal will be recorded in the official record of the game. Any such appeal must be made in writing, must clearly state the grounds for such claim, must be signed by the team coach, and must be delivered to the Chief Referee no later than one hour following the end of the game.
- 12.2. Untimely or incorrect appeals will not be recorded on the Official Game Sheet and will not be considered.
- 12.3. Appeals will not be considered if they relate to decisions on:
 - 12.3.1. offside positions;
 - 12.3.2. the correct scoring of goals;
 - 12.3.3. the location of players on the pitch;
 - 12.3.4. face-off spots; and
 - 12.3.5. any other penalties (imposed or otherwise).

13. Participants' liability under disciplinary offences at the Tournament

- 13.1. Participants' liability for penalties, for Game Misconduct, and for Match Penalties, will be determined by the Referee Board and the Executive Directorate.
- 13.2. The procedure for determining penalties and the disqualification of players and team officials following misconduct during the Tournament is given in Appendix 3 of these Conditions.
- 13.3. The Referee Board is obliged to forewarn Chief Referees as to which of the players will miss the next match, and for what reason.

14. Official Tournament ceremonies

- 14.1. The Opening Ceremonies for the East and West Groups on 21 April 2018 will involve up to six people from each team (the goal keeper and five field players). All participants must be in full kit, on skates, with sticks but without helmets.
- 14.2. The awards ceremonies on 23 April 2018 will involve the entire teams taking I, II and III place in the East and West Groups. Players on these teams should appear in full kit, on skates, with sticks, but without helmets.
- 14.3. The awards ceremonies will also involve players from other teams receiving awards for special nominations but not in teams taking I, II or III place as at the end of the East and West Group rounds. Players on these teams should be in full kit or the team outer clothing, but without sticks and without helmets.
- 14.4. The full squads of both teams playing in the Super Final will take part in the awards ceremony on 25 April 2018. Players on these teams should appear in full kit, on skates, with sticks, but without helmets.

15. Official Tournament photo sessions

- 15.1. The following mandatory photo sessions will take place during the Tournament.
 - 15.1.1. The following photo sessions will take place prior to the start of the Tournament (but no later than 30 minutes prior to training or, where a team, for any good reason, is not having a training session, no later than one hour prior to the start of such team's first match in the Tournament):

- 15.1.1.1. each member of a team, in full kit, on skates, without a stick and without a helmet;
- 15.1.1.2. the coach/coaches and all team officials, as well as all team management included in the Official Application; and
- 15.1.1.3. The full team will be photographed, together with their coach/coaches (the players in full kit, on skates, without sticks and without helmets);
- 15.1.2. The following photo sessions will take place after the awards ceremony on 23 April 2018:
 - 15.1.2.1. those teams taking I, II and III place in the East and West Groups, including the full team with their coach/coaches (players to be in full kit, on skates, without sticks and without helmets);
 - 15.1.2.2. the best players, nominated for special awards (in full kit, on skates, without sticks and without helmets). Where players not on a I, II, or III-placed team at the end of the East and West Group rounds receive an award they will take part in photo sessions in sports kit or in the team outer clothing, on skates, without sticks and without helmets;
 - 15.1.2.3. the best coaches of the East and West Groups; and
 - 15.1.2.4. the captains of those teams receiving the “fair play” award (for the most disciplined teams) in the East and West Groups (in full kit, on skates, without sticks and without helmets). Where they are captains of teams receiving this award but not placed I, II or III at the end of the East and West Group rounds they may take part in the photo session in sports gear or in their team outer clothing, on skates, without sticks and without helmets.
- 15.1.3. The following photo sessions will take place after the awards ceremony on 23 April 2018:
 - 15.1.3.1. the winning team in the Gazprom Neft Cup Super Final. The full team will be photographed, together with their coach/coaches (the players in full kit, on skates, without sticks and without helmets);
 - 15.1.3.2. participating teams winning special prizes in the Super Final, including the full team, with their coach/coaches (the players in full kit, on skates, without sticks and without helmets); and
 - 15.1.3.3. the best players in the Super Final (in full kit, on skates, without sticks and without helmets).

16. Tournament training sessions

- 16.1. Each team is entitled to one training session of no more than 45 minutes.
- 16.2. The schedule of training sessions will be compiled on the basis of team arrivals and will be forwarded to teams in advance.
- 16.3. Pucks to be used in training sessions will be set out on team benches by rink staff.

17. Skate sharpening for Tournament participants

- 17.1. Skate sharpening is available at each rink from 8:00 am until the end of the final match or training session of the day, for the duration of the Tournament. Skate sharpening is free for all Tournament participants.

18. Safety of Tournament participants

- 18.1. To ensure the safety of all Tournament participants, all organisations directly involved in preparations for or the management of the Tournament (regardless of their legal status or ownership) must be in possession of documentation governing their conduct pursuant to Order No. 44 of the Council for the Development of Physical Culture and Sport of the Russian Federation “On Safety and the Prevention of Injury in Physical Education and Sport”.

19. Financial conditions for the Tournament

- 19.1. All expenses relating to the Tournament will be covered by Gazprom Neft PJSC, including the following:
 - 19.1.1. return transportation of out-of-town teams from airports or railway stations to their accommodation and, on those days on which games are played, return transportation from their accommodation to game venues;
 - 19.1.2. accommodation and three meals per day for those participants listed in Official Applications, for the duration of the Tournament;
 - 19.1.3. the procurement and/or production of trophies and souvenirs;
 - 19.1.4. rental of sports and ancillary facilities, and sports and technological equipment and supplies;
 - 19.1.5. the provision of qualified medical personnel throughout all games;
 - 19.1.6. public cultural and media events;
 - 19.1.7. travel expenses from Sochi to Omsk for the winner of the West Group preliminary rounds, as well as return travel expenses to their home destination; and
 - 19.1.8. preparation and management of the Opening and Closing ceremonies, as well as other expenses related to preparation for and management of the Tournament, excluding expenses specified in Clause 19.2 of these Conditions.
- 19.2. Out-of-town teams from other cities/towns are required to cover the following expenses:
 - 19.2.1. return team travel to Tournament venues; and

19.2.2. all travel, accommodation, subsistence and transport services for any persons accompanying the team and not listed in the Official Application (including players' parents).

19.3. The KHL is responsible for providing:

- payments in respect of rent and the preparation of sports facilities involved in running the tournament ;
- payments in respect of hotel services for non-local participants and Tournament guests;
- payments for organising food (subsistence) for Tournament participants;
- payments in respect of preparations for, the organisation of, and services supporting Tournament games;
- providing additional sports kit, equipment and accessories, as well as awards and prizes made to participating teams and team support staff.

20. Other Conditions

20.1. On all other matters not covered by these Conditions Tournament participants are governed by the decisions of the Organising Committee and the Executive Directorate.

20.2. The Organising Committee has the right to supplement and/or amend these Conditions provided that any such amendments do not result in any increase in the total costs of the Tournament or its duration, and provided that they do not contravene the Regulations of the Gazprom Neft Cup KHL Kids' Hockey Tournament as approved by Gazprom Neft PJSC and the Kontinental Hockey League.
